NOTICE OF RACE

The RRS, the Prescriptions of US Sailing and local class rules shall govern this entire series.

Race dates shall be November 14th, December 12th, January 9th and February 13th.

Two races per day are scheduled. First Warning each day is 1130 hrs.

The intended racing area will be the Berkeley Circle area. Courses will be windward/leeward courses set up using inflatable marks.

The low point scoring system RRS A4 shall be used. A minimum of one race shall be completed to constitute a series. If four races are completed, each yacht's worst score will be excluded. If seven or more races are completed, each yacht's two worst scores will be excluded. This series shall be scored as a series longer than a regatta (A9).

Entry is open to the following classes:

J120 J111 J105 Melges 24 J70 Moore 24 J24

A minimum of four yachts is required for a class to participate. Other classes may participate provided the class PHRF rating is no higher than 150. To qualify, classes must meet the minimum by November 9th.
